#### **Statement of Intent**

New Brighton Primary School believes that, in order to facilitate teaching and learning, positive behaviour must be demonstrated in all aspects of school life. The school is committed to:

- Promoting a therapeutic approach.
- Promoting desired behaviour.
- Promoting self-esteem, self-discipline, and positive relationships based on mutual respect.
- Ensuring equality and fair treatment for all.
- Praising and rewarding good behaviour.
- Challenging and disciplining misbehaviour.
- Providing a safe environment free from disruption, violence, discrimination, bullying and any form of harassment.
- Encouraging positive relationships with parents.
- Developing positive relationships with pupils to enable early intervention.
- A shared approach which involves pupils in the implementation of the school's policy and associated procedures.
- Promoting a culture of praise and encouragement in which all pupils can achieve.

Appropriate sanctions will be used where a pupil's behaviour falls below the standard that is expected, alongside support to prevent recurring misbehaviour.

The school acknowledges that behaviour can sometimes be the result of educational needs, mental health issues, or other needs or vulnerabilities, and will address these needs via an individualised graduated response.

To help reduce the likelihood of behavioural issues related to social, emotional or mental health (SEMH), the school will aim to create a safe and calm environment in which positive mental health and wellbeing are promoted and pupils are taught to be resilient. The school will aim to promote resilience as part of a whole-school approach using the following methods:

- **Culture, ethos and environment** the health and wellbeing of pupils and staff is promoted through the informal curriculum, including leadership practice, policies, values and attitudes, alongside the social and physical environment
- Teaching the curriculum is used to develop pupils' knowledge about health and wellbeing
- Community engagement the school proactively engages with parents, outside agencies and the wider community to promote consistent support for pupils' health and wellbeing

All staff will be made aware of how potentially traumatic adverse childhood experiences, including abuse and neglect, can impact on a pupil's mental health, behaviour, and education. Where vulnerable pupils or groups are identified, provision will be made to support and promote their positive mental health. The school's Social, Emotional and Mental

Health (SEMH) Policy outlines the specific procedures that will be used to assess these pupils for any SEMH-related difficulties that could affect their behaviour.

## 1. Legal framework

# 2. Roles and responsibilities

# The governing board will have overall responsibility for:

- Making a statement of behaviour principles, and providing guidance for the headteacher on promoting good behaviour where appropriate.
- Ensuring that this policy, as written, does not discriminate on any grounds, including, but not limited to, age, disability, gender reassignment, gender identity, marriage and civil partnership, race, religion or belief, sex and sexual orientation.
- Promoting a whole-school culture where calm, dignity and structure encompass every space and activity.
- Handling complaints regarding this policy, as outlined in the school's Complaints Procedures Policy.
- Ensuring this policy is published on the school website.

#### The headteacher will be responsible for:

- The monitoring and implementation of this policy and of the behaviour procedures at the school. This includes monitoring the policy's effectiveness in addressing any SEMH-related drivers of poor behaviour.
- Acting in accordance with the statement of behaviour principles made by the governing board, and having any regard to guidance provided by the governing board on promoting good behaviour.
- Establishing high expectations of pupils' conduct and behaviour, and implementing measures to achieve this.
- Determining the school rules and any disciplinary sanctions for breaking the rules.
- The day-to-day implementation of this policy.
- Publicising this policy in writing to staff, parents and pupils at least once a year.
- Reporting to the governing board on the implementation of this policy, including its
  effectiveness in addressing any SEMH-related issues that could be driving disruptive
  behaviour.

#### The safeguarding and pastoral lead will be responsible for:

- Overseeing the whole-school approach to mental health, including how this is reflected in this policy, how staff are supported with managing pupils with SEMH-related behavioural difficulties, and how the school engages pupils and parents with regards to the behaviour of pupils with SEMH difficulties.
- Supporting behaviour management in line with the SEMH Policy.

#### The SENDCo will be responsible for:

- Collaborating with the governing board, headteacher and the senior mental health lead, as part of the SLT, to determine the strategic development of behaviour and SEMH policies and provisions in the school.
- Undertaking day-to-day responsibilities for the successful operation of the behaviour and SEMH policies to support pupils with SEND, in line with the school's Special Educational Needs and Disabilities (SEND) Policy.
- Supporting teachers in the further assessment of a pupil's strengths and areas for improvement and advising on the effective implementation of support.

#### Teaching staff will be responsible for:

- Knowing their pupils and developing positive relationships with them.
- Planning and reviewing support for pupils with behavioural difficulties in collaboration with parents, the SENDCo and, where appropriate, the pupils themselves.
- Aiming to teach all pupils the full curriculum, whatever their prior attainment.
- Planning lessons to address potential areas of difficulty to ensure that there are no barriers to every pupil achieving their full potential, and that every pupil with behavioural difficulties will be able to study the full national curriculum.
- Teaching and modelling positive behaviour and relationships, demonstrating high standards expected of our children.

- Setting clear expectations for all pupils at the start of each day/session.
- Being responsible and accountable for the progress and development of the pupils in their class.
- Not tolerating disruption and taking appropriate action to restore acceptable standards of behaviour.

All members of staff, including teaching and support staff, and volunteers will be responsible for:

- Adhering to this policy and applying it consistently and fairly.
- Supporting pupils in adhering to this policy.
- Promoting a supportive and high-quality learning environment.
- Modelling and setting high expectations of behaviour.
- Being aware of the signs of behavioural difficulties and implementing de-escalation strategies
- Being aware of the needs, outcomes sought, and support provided to any pupils with specific behavioural needs.
- Offering support to colleagues when necessary ('Cup of tea' strategy for example)
- Keeping the relevant people up-to-date with any changes in behaviour. The relevant people include:

Headteacher.

Senior Leadership Team.

Class teachers.

SENDCo.

Pastoral team.

Pupils will be responsible for (include class pledge behaviours here):

- Their own behaviour both inside school and out in the wider community.
- Reporting any unacceptable behaviour to a member of staff.

Parents will be responsible for:

- Supporting their child in adhering to the school rules and reinforcing this at home.
- Informing the school of any changes in circumstances which may affect their child's behaviour.

#### 3. Definitions

For the purposes of this policy, the school will define "serious unacceptable behaviour" as any behaviour which may cause harm to oneself or others, damage the reputation of the school within the wider community, and/or any illegal behaviour. This will include, but is not limited to, the following:

- **Discrimination** not giving equal respect to an individual on the basis of age, disability, gender identity, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation
- Harassment behaviour towards others which is unwanted, offensive and affects the dignity of the individual or group of individuals

- Vexatious behaviour deliberately acting in a manner so as to cause annoyance or irritation
- **Bullying** a type of harassment which involves personal abuse or persistent actions which humiliate, intimidate, frighten or demean the individual being bullied
- **Cyberbullying** the use of electronic communication to bully a person, typically by sending messages of an intimidating or threatening nature
- Possession of legal or illegal drugs, alcohol or tobacco
- Possession of banned items
- Truancy and running away from school
- Refusing to comply with disciplinary sanctions
- Theft
- Verbal abuse, including swearing, racist remarks and threatening language
- Fighting and aggression
- Persistent disobedience or disruptive behaviour
- Extreme behaviour, such as violence and serious vandalism
- Any behaviour that threatens safety or presents a serious danger
- Any behaviour that seriously inhibits the learning of pupils
- Any behaviour that requires the immediate attention of a staff member

For the purposes of this policy, the school will define "low-level unacceptable behaviour" as any behaviour which may disrupt the education of the perpetrator and/or other pupils, including, but not limited to, the following:

- Low-level disruption
- Failure to complete classwork
- Being disrespectful
- Use of mobile phones without permission

"Low-level unacceptable behaviour" may be escalated to "serious unacceptable behaviour", depending on the severity of the behaviour.

# 4. Staff induction, development and support

All new staff will be inducted clearly into the school's behaviour culture to ensure they understand its rules and routines and how best to support all pupils to participate in creating the culture of the school. Staff will be provided with bespoke training, where necessary, on the needs of pupils at the school to enable behaviour to be managed consistently.

The SLT will consider any appropriate training which is required for staff to meet their duties and functions in accordance with this policy, including on understanding matters which may affect a pupil's behaviour, e.g. SEND and mental health needs.

The SLT and the headteacher will review staff training needs regularly, and in response to any serious or persistent behaviour issues disrupting the running of the school.

# 5. Managing behaviour

Staff will be encouraged to use preventative strategies to minimise disruptive or unacceptable behaviour and maintain a positive, focussed learning environment in school. However, instances of unacceptable behaviour will be taken seriously and dealt with immediately. Staff will respond promptly, predictably and with confidence to maintain a calm, safe learning environment using a restorative approach- pupils displaying disruptive behaviour will be given options using the language of choice (e.g. 'You can finish your work now or complete it in reflection time during break') Staff will consider afterwards how to prevent such behaviour from recurring.

Staff will use the behaviour toolkit (appendix 2) to support maintaining a positive learning environment. Behavioural incidents beyond one off low-level disruption will be recorded on CPOMS by the member of staff dealing with the incident. As part of school's restorative behaviour approach incidents will be recorded in the following way:

#### Behaviour:

This is can be split into two further categories, **Bullying** and **RSH** (Racial, Sexual and Homophobic)

#### **Bullying:**

 Bullying is the repetitive, intentional hurting of one person or group by another person or group, where the relationship involves an imbalance of power. It can happen face to face or online

#### RSH (Racial, Sexual or Homophobic behaviours):

- Zero tolerance
- Verbal or physical
- Can not be excused as 'boys being boys' e.g. lifting skirts, pulling trousers down

'Normal' or repeated low-level Behaviour incidents to be recorded using ABCDE

- A = Antecedent: What happened before the behaviour / trigger
- B = Behaviour displayed (this should not be the majority of the record)
- C = Consequence for the child
- D = Desired outcome (reflection with the child)
- E = Evaluation: Is there a pattern with the antecedent? What could be done to stop / reduce the behaviour? Was the consequence effective? Could have been done differently?

As a legal record it is very important that behavioural incidents are recorded **factually** on CPOMS. Descriptions of a child's behaviour also only serve one purpose - for teachers/support staff to inform SLT that a child is struggling. They are not useful in helping staff to reflect on what else they could be doing differently to support a child's behaviour.

The pastoral lead, head and deputy will be able to view a record of reported incidents to help identify pupils whose behaviour may indicate potential mental health or safeguarding problems. All staff will be alerted to changes in a pupil's behaviour that could indicate they need help or protection.

Support, such as targeted discussions with pupils, a meeting with parents, and inquiries into circumstances outside of school by the class teacher, DSL or phase leaders, will be provided alongside the use of appropriate sanctions to prevent the misbehaviour recurring. After an initial incident of negative behaviour, the following sanctions will be considered, with staff using their professional judgement and experience to determine what is appropriate:

- Issuing a verbal reprimand and reminder of the expected behaviour
- Loss of break or lunch for 'reflection time'
- School-based community service, e.g. tidying the classroom

Where a pupil's misbehaviour is causing significant disruption or is deemed serious enough by a staff member, the following procedures will be followed:

- The pupil is sent to their relevant phase leader (or senior teacher) who will record details of the incident and that pupil had to be referred to them on CPOMS.
- Where disruption is significant, further investigation of appropriate responses will be undertaken by class teacher possibly in conjunction with phase or pastoral lead.
- Where deemed necessary, e.g. after other behavioural strategies in the classroom have been attempted or the behaviour is so extreme as to warrant immediate removal, the pupil will be removed from the classroom – the pastoral lead/phase leader will determine the period the pupil will be removed from the classroom, as well as any reflection time.
- The phase leader/class teacher will inform the pupil's parents on the same day, where possible, following a decision to remove their child from the classroom, and invite them to discuss the incident.

Following repeated incidents of unacceptable behaviour, the following sanctions will be implemented:

- Where the above is not effective in eliminating poor behaviour the pupil will be sent to a senior member of staff.
- The headteacher will consider whether the pupil should be suspended, in line with the school's Suspension and Exclusion Policy, and will determine the length of the suspension.
- Although unacceptable behaviour does not necessarily mean a pupil has SEND, an assessment will be carried out at this stage to determine whether there are any undiagnosed learning or communication difficulties, or mental health issues that may be contributing to the pupil's behaviour.
- Where a pupil is identified as having SEMH-related difficulties, SEND support will be put in place from the school's SEND budget.

Where SEND is not identified, but the school staff determines that support is still
required for the pupil, an Individual Behaviour Plan will be created to outline the
necessary provisions in place.

Following further incidents of unacceptable behaviour, the following sanctions will be implemented:

The headteacher will consider whether a permanent exclusion is necessary, in line with the school's Suspension and Exclusion Policy, alongside alternative options such as a managed move or off-site direction.

For discipline to be lawful, the school will ensure that:

- The decision to discipline a pupil is made by a paid member of school staff, or a member of staff authorised to do so by the headteacher.
- The decision to discipline a pupil is made on the school premises or whilst the pupil is under the charge of a member of staff, such as during an educational trip or visit.
- The decision to discipline a pupil is reasonable and will not discriminate on any grounds, e.g. equality, SEND or human rights.

The school will ensure that all discipline is reasonable in all circumstances, and will consider the pupil's age, religious requirements, SEMH needs, any SEND, and any other contributing factors, e.g. bullying, safeguarding or home life issues.

# 6. Prevention strategies, intervention, and sanctions for unacceptable behaviour

This section outlines the school's strategies for promoting positive behaviour/preventing unacceptable behaviour and initial interventions, minimising the severity of incidents, and using sanctions and support effectively and appropriately to improve pupils' behaviour in the future.

#### Initial interventions

A range of initial intervention strategies to help pupils manage their behaviour and reduce the likelihood of more severe sanctions will be used. Support will consider the pupil's specific needs and may be delivered outside of the classroom, in small groups or in one-to-one activities. A system will be in place to ensure relevant members of the SLT and pastoral staff are aware of any pupil that is:

- Persistently misbehaving
- Not improving their behaviour following low-level sanctions
- Displaying a sudden change in behaviour from previous patterns of behaviour

Examples of initial interventions to address misbehaviour will include, but are not limited to, the following:

- Frequently engaging with parents
- Support from learning mentors both within and outside of class
- Providing mentoring and coaching

- Short-term positive behaviour charts
- Long-term behaviour plans (IBP)
- Engagement with local partners and agencies
- Where the pupil has SEND, an assessment of whether appropriate provision is in place to support the pupil, and if the pupil has an EHC plan, contact with the LA to consider a review of the plan
- Inclusion Team referral
- EP drop Ins

A multi-agency assessment, such as an early help assessment, that goes beyond a pupil's education will be considered where serious concerns about a pupil's behaviour exist.

#### **PSHE** curriculum

Positive behaviour will be taught to all pupils as part of the PSHE curriculum, in order to enable them to understand what behaviour is expected and encouraged and what is unacceptable. Positive reinforcement will be used by staff where expectations are met to acknowledge good behaviour and encourage repetition. The PSHE curriculum will focus on defining positive behaviour and making it clear what this looks like, including the key habits and routines. Pupils will be rewarded for demonstrating good behaviour through team points and Class Dojo points. Additionally, the school Owl awards system will be used in weekly assemblies to reinforce, promote and encourage positive behaviour. Children chosen by class teachers will receive a certificate for demonstrating one of our core values (mutual respect, confidence, responsibility, resilience, community involvement and independence) which support our PSHE curriculum.

Routine will be used to teach and reinforce the expected behaviours of all pupils. Appropriate and reasonable adjustments to routines for pupils with additional needs, e.g. SEND, will be made. Consistent and clear language will be used when acknowledging positive behaviour and addressing misbehaviour.

#### Positive teacher-pupil relationships

Positive teacher-pupil relationships are key to combating unacceptable behaviour. The school will focus heavily on forming positive relationships based on predictability, fairness and trust to allow teachers to understand their pupils and create a strong foundation from which behavioural change can take place.

#### Whole school preventative strategies.

As a school we believe that taking a preventative approach to promote positive behaviour is key to successful behaviour management. The following strategies will be used to promote positive behaviour and foster a positive environment within school:

- Use of visual timetable in all classrooms
- Class pledges displayed and referred to when necessary in all classrooms
- Planning adapted to meet pupil needs and promote engagement with learning

- High behaviour and behaviour for learning expectations clearly communicated by all staff and understood by all pupils
- All staff will get to know the children they work with and build positive relationships based on mutual respect.
- Pupils are greeted at the class door at the start of each session by an adult to set expectations and a calm atmosphere
- Clear communication about planning/expectations between class teachers, TAs and supply staff
- Use of sensory breaks when needed
- Change of conversation or distraction to help de-escalate
- Regular communication with parents regarding pupils whom there may be a behaviour concern over.

#### Preventative measures for pupils with SEND

Behaviour will always be considered in relation to a pupil's SEND. If it is deemed that a pupil's SEND has contributed to their misbehaviour, the school will consider whether it is appropriate and lawful to sanction the pupil.

Where a pupil is identified as having SEND, the graduated approach will be used to assess, plan, deliver and review the impact of support being provided. Have reasonable adaptations been made for the child?

The school will aim to anticipate likely triggers of misbehaviour and put in place support to prevent these, taking into account the specific circumstances and requirements of the pupil concerned. Measures the school will implement where appropriate include, but are not limited to, the following:

- Short, planned movement breaks for a pupil whose SEND means they find it difficult to sit still for long
- Ensuring a pupil with visual or hearing impairment is seated in sight of the teacher
- Adjusting uniform requirements for a pupil with sensory issues or relevant medical condition
- Support from learning mentors and support staff
- Training for staff in understanding all neurodevelopmental conditions
- Adaptive teaching strategies
- Flexible seating approaches
- Access to sensory equipment and/or quiet space within class
- Carefully planned curriculum that engages and excited all pupils

#### **De-escalation strategies**

Where negative behaviour is present, staff members will implement de-escalation strategies to diffuse the situation.

This will include effective strategies taken from My Happy Mind, the Therapeautic school approach and Team Teach training.

#### **Reactive strategies**

While we recognise that preventative strategies are key in maintaining positive behaviour there are times when staff will need to react to poor behaviour. In these cases we use the following reactive approaches:

- Application of an appropriate sanction (listed previously)
- Provide pupils with strategies they can use to avoid a repetition of the behaviour in question
- Change of seat or position in class
- Use of reflection time to allow pupils to regulate and have constructive conversation about behaviour expectations

#### **Physical intervention**

A number of key staff have received Team Teach training. This is an ongoing process and more staff will be trained as and when spaces become available.

If a pupil reaches crisis point and requires physical intervention, Team Teach trained staff will respond in a proportionate and necessary way ensuring that pupils and staff are kept safe.

#### Removal from the classroom

The school may decide to remove pupils from the classroom for a limited period, at the instruction of a member of staff.

The pupil will be moved to a room that is:

- In an appropriate area of the school
- Stocked with appropriate resources
- Suitable to learn and refocus
- Supervised by trained members of staff

The school will only remove pupils from the classroom where absolutely necessary and for the following reasons:

- To maintain the safety of all pupils and restore stability following an unreasonably high level of disruption
- To enable disruptive pupils to be taken to a place where education can continue in a managed environment
- To allow the pupil to regain calm in a safe space

The school will ensure that pupils' health and safety is not compromised during their time away from the classroom, and that any additional requirements, such as SEND needs, are met.

The amount of time that a pupil spends removed from the classroom will be up to the school to decide. This could be for more than one school day. The school will ensure that the pupil is not removed from the classroom any longer than necessary.

The staff member in charge and supervising the pupil will decide what the pupil may and may not do during their time spent removed from the classroom. The headteacher will request that the pupil's class teachers set them appropriate work to complete.

The headteacher will establish a clear process for the reintegration of a pupil who has been removed from the classroom when it is deemed appropriate and safe for them to return. Consideration will be given to what support is needed to help the pupil return and meet the expected standards of behaviour. Reintegration meetings will be held between the school, pupil and their parents, and other agencies if relevant, where necessary.

Pupils will be permitted to eat during the allocated times of the school day and may use the toilet as required.

#### 7. Sexual abuse and discrimination

The school will prohibit all forms of sexual abuse and discrimination, including sexual harassment, gender-based bullying and sexual violence. The school's procedures for handling peer-on-peer sexual abuse and discrimination are detailed in the Child-on-child Abuse Policy. Any incidents will be recorded on the school CPOMS under the RSH heading so that they can be tracked and monitored.

The school will respond promptly and appropriately to any sexual harassment complaints in line with the Child Protection and Safeguarding Policy; appropriate steps will be taken to stop the harassment and prevent any reoccurrence. Discipline for incidents of sexual harassment will be determined based on the nature of the case, the ages of those involved and any previous related incidents.

# 8. Smoking and controlled substances

The school will follow the procedures outlined in its Smoke-free Policy and Pupil Drug and Alcohol Policy when managing behaviour in regard to smoking and nicotine products, legal and illegal drugs, and alcohol.

In accordance with the Health Act 2006, the school is a smoke-free environment. Parents, visitors, staff and pupils will be instructed not to smoke on school grounds. Pupils will not be permitted to bring smoking materials or nicotine products to school.

The school will have a zero-tolerance policy on illegal drugs, legal highs and other controlled substances. Where incidents with pupils related to controlled substances occur, the school will follow the procedures outlined in the Pupil Drug and Alcohol Policy and Child Protection and Safeguarding Policy.

# 9. Effective classroom management

Well-managed classrooms are paramount to promoting positive behaviour. Effective classroom management will allow staff to:

- Start the year with clear sets of rules and routines that are understood by all pupils (class pledge)
- Establish agreed rewards and positive reinforcements.
- Establish clear responses for handling behavioural incidents.

- Encourage respect and development of positive relationships.
- Make effective use of the physical space available.
- Have well-planned, adapted lessons to meet the needs of all pupils

Subject to reasonable adjustments, e.g. those made for pupils whose SEND may affect their behaviour, pupils will be expected to follow their Class Pledge (see appendix)

#### Classroom rules and routines

The school will have an established set of clear, comprehensive and enforceable classroom rules which define what is acceptable behaviour and what the consequences are if rules are not adhered to. Attention is given to how rules are worded, such as the use of positive language rather than negative, e.g. "act respectfully towards your peers and teachers", rather than "do not act disrespectfully towards your peers and teachers".

The school will also have an established set of classroom routines to help pupils work well, in the understanding that behavioural problems can arise due to the lack of a consistent routine. This includes teachers ensuring that before lessons begin, they have the full attention of all pupils, then explaining the task clearly so all pupils understand what they are supposed to be doing.

The headteacher will ensure all teachers understand classroom rules and routines and how to enforce them, including any sanctions for not following the rules.

Teachers will support pupils to understand and follow classroom rules and routines. Teachers will inform pupils of classroom rules and routines at the beginning of the academic year and revisit these daily. Where appropriate, teachers will explain the rationale behind the rules and routines to help pupils understand why they are needed, and will model rules and routines to ensure pupils understand them. Teachers will also explain clearly to pupils what will happen if they breach any classroom rules to ensure pupils are aware of the sanctions that may be imposed.

To support pupils' continued awareness and understanding of classroom rules and routines, teachers will reinforce them in a range of ways, e.g. placing posters of the rules on classroom walls and providing regular verbal reminders of the routines. Teachers will also ensure that classroom rules and routines remain consistent and are practised throughout the year to create a more productive and enjoyable environment.

At the beginning of the school year, once the classroom rules have been devised, pupils will be provided with a Class Pledge which they are required to read and sign. All rules outlined in the Class Pledge are applicable to pupils' behaviour elsewhere on the school premises and outside of the school – teachers will ensure that pupils understand this.

#### The classroom environment

The school understands that a well-structured classroom environment is paramount to promoting positive behaviour. This includes the teacher positioning themselves effectively within the classroom, e.g. wherever possible, teachers avoid standing with their backs to pupils and ensure they have full view of the room at all times.

Teachers will employ strategic seating arrangements to promote positive behaviour and enable it to be noticed early, such as:

- Seating those who need support to behave positively closest to, and facing, the teacher.
- Ensuring the teacher can see pupils' faces, that pupils can see one another, and that they can see the board.
- Ensuring the teacher can move around the room so that behaviour can be monitored effectively.
- Adaptive teaching strategies to reduce the risk of poor behaviour.

## 10. Behaviour outside of school premises

Pupils at the school must agree to represent the school in a positive manner. The guidance laid out in the Class Pledge will apply both inside school and out in the wider community, particularly if the pupil is dressed in school uniform.

Staff can discipline pupils for misbehaviour outside of the school premises, including conduct online, when the pupil is:

- Wearing school uniform.
- Travelling to or from school.
- Taking part in any school-related activity.
- In any way identifiable as being a pupil at the school.

Staff may also discipline pupils for misbehaviour outside the school premises, including conduct online, that:

- Could negatively affect the reputation of the school.
- Could pose a threat to another pupil, a member of staff at the school, or a member of the public.
- Could have repercussions for the orderly running of the school.

Any bullying witnessed outside of the school premises and reported to the school will be dealt with in accordance with the Anti-bullying Policy.

The school will impose the same sanctions for bullying incidents and non-criminal misbehaviour witnessed or reported outside of the school premises as would be imposed for the same behaviour conducted on school premises. In all cases of unacceptable behaviour outside of the school premises, staff will only impose sanctions once the pupil has returned to the school premises or when under the supervision of a member of staff.

Complaints from members of the public about the behaviour of pupils from the school are taken very seriously and will be dealt with in accordance with the Complaints Procedures Policy.

#### 11. Data collection and behaviour evaluation

The school will collect data from a variety of sources, including:

- Behaviour incident data, including on removal from the classroom
- Attendance, permanent exclusion and suspension data
- Use of alternative provisions, off-site directions and managed moves

The data will be monitored and objectively analysed termly by the headteacher and the SLT. Attempts will be made to identify possible factors contributing to the behaviour, any system problems or inadequacies with existing support. The data will also be analysed considering the protected characteristics under the Equality Act 2010 to inform school policies and practice.

# 12. Monitoring and review

This policy will be reviewed by the headteacher and senior mental health lead on an annual basis; they will make any necessary changes and communicate these to all members of staff and relevant stakeholders.

This policy will be made available for Ofsted inspections and reviews by the lead inspector, upon request.

The next scheduled review date for this policy is October 2025.

Special Note
In extreme circumstances a pupil may be excluded from school either for a fixed period or permanently. New Brighton Primary would only consider exclusion in extreme circumstances when all other approaches to behaviour management have failed. A pupil could be excluded, although not necessarily, under the following circumstances:

- where there is enough evidence that the pupil has committed a serious one-off offence.
- where the pupil is accused of a serious criminal offence away from school and the headteachers, in the best interests of the pupil and others in school, feel that they should be educated off site for a period of time.
- where allowing the pupil to remain in school would seriously harm the education or welfare of the pupil or others in the school.

#### **Lunchtime behaviour escalation:**

Pupil misbehaves.	STEP 1.  Lunch supervisor reminds pupil of behaviour expectations.
Pupil continues to misbehave.	STEP 2.  Lunch supervisor reminds pupil again and warns if there is a repeat they will be sent in to Dee.
